





THE STORY YOU TELL

Federation's story is the story of our people. It is the story of each of us today. Our mission, to engage and mobilize our community to preserve and enhance Jewish life, begins in St. Louis and extends to Israel and anywhere there is a need. Our community is able to help in Ukraine or the former Soviet Union because of our strong partnerships with international agencies. Our children are able to experience Jewish life in many different ways through day schools, summer camps, and trips to Israel. Our elderly population is able to share their history at the Holocaust Museum & Learning Center or Brodsky Library, while living lives of dignity through the Naturally Occurring Retirement Community or Covenant Place. Federation makes these things possible: buoyed by our new strategic plan in 2010, through the assistance of a strong foundation of long-time volunteers and staff, and energized by new lay and professional leadership, our organization remains vital, vibrant and promising. These achievements, and so many more, have been possible because of your continued support of our annual campaign and targeted giving. Here are some highlights from the year:

Community Study:

Thanks to the generous support of Harvey and Terry Hieken, with additional support from the Morton J. and Morton D. May Fund of the Greater St. Louis Community Foundation, the Lubin-Green Foundation, and community donors like you, we embarked on our first community study in 20 years. Les Sterman chaired a community advisory board to make sure that we canvassed our community agencies and organizations, to find out the information that would be helpful to them. Staffed by Federation Senior Planner, Susan Scribner, we engaged JPAR (Jewish Policy & Action Research), an internationally recognized research group, to create a questionnaire was used to survey over 1,000 members of our community in Spring 2014. The results will be announced in early 2015 and will provide important guideposts for all of our community to strengthen their work and potential growth in the future.

Celebration of NORC's 10th Anniversary:

This year, we celebrated the 10th anniversary of the St. Louis Naturally Occurring Retirement Community (NORC), an innovative project that provides services and programs to keep seniors living independently in their own homes. The NORC was started in 2004 after research had shown that "aging in place" was the best way to increase and maintain health and longevity. The NORC leverages volunteers to serve our seniors in their homes, and organizes programs at the Jewish Community Center, Covenant Place and throughout the community to keep seniors engaged and vibrant. Led by its original director, Karen Berry Elbert, and her professional team, the NORC is proud to have received a significant endowment this year from Alvin and Ruth Siteman to help offset the uncertainty of government funds on which it relies.

Responding in times of Crisis:

Just before Passover, we all received news of the terrible tragedy in Kansas City in which three people were killed on the campuses of the Jewish Community Center and Shalom Place senior living home. In close partnership with Karen Aroesty, regional director of the MO/So. IL Anti-Defamation League, and Batya Abramson-Goldstein, executive director of our Jewish Community Relations Council (JCRC), Federation provided security resources to address and respond to the uncertainty of the situation in real time.


The tragedy in Kansas City was followed by one of the more difficult summers for our people. In June, the kidnapping and killing of three boys in Israel galvanized Jewish communities all over the world. The 2014 Gaza crisis that followed saw Israel terrorized by missiles fired at civilian populations and the discovery of an extensive network of tunnels designed to bring maximum damages directly to civilians. Federation, working in close partnership with JCRC, convened three gatherings in a period of four weeks drawing over 1,000 community members to remember the lives of those boys, learn about the need and complexity of the Gaza crisis, and come together in solidarity for all in Israel who were living under these attacks.

Federation's support was tangible as well, raising over \$470,000 to provide humanitarian assistance through our partner agencies in Israel. Your funds allowed us to support the movement of thousands of children from southern Israel to the relative safe harbor of the north; to outfit bomb shelters to meet the needs of the disabled; and for counseling support through the Israel Trauma Coalition and our other overseas partners.

Community Development:

Federation works not only to help those in need, but also to encourage continued Jewish education and engagement in our community. To aid its ability to do that, this year the Central Agency for Jewish Education (CAJE) began to explore the idea of integrating with Jewish Federation, as we built out our community development strategies. Working closely with its executive director, Sonia Dobinsky, Federation and CAJE are aligning to leverage our resources even more effectively to create new points of access into Jewish life, grow our educational footprint through the expansion of a community speakers series, PJ Library and support for our congregations, and build on a foundation of strong Israel programming supported through Birthright and The Rubin Israel Experience. And, thanks to the vision and support of Ron and Pam Rubin, we are excited to announce that the Wexner Heritage Fellows program will come back to St. Louis in the summer of 2015. Look for the integration with CAJE and our new Community Development department to include the Millstone Institute, our inclusion coordinator, the interfaith initiative, and more to be complete as of early 2015. By bringing these groups together, we look forward to further enhancing Jewish identity, engagement and education in our community.

2013-14 has been a busy year. Federation remains as vital as ever to support a vibrant St. Louis community: our agencies, synagogues and individuals creating lives of meaning and value in service to all. We thank you for your continued support of the Jewish community to make this, and so much more, possible.






